#### SURVEYING SERVICES:

- On-hire / Off-hire Survey: Survey of vessels undertaken either before the vessel is delivered to a charter or after its delivery. The survey report includes a detailed description of vessel's cargo spaces/ deck areas, structural condition, cargo space cleanliness, bunkers onboard, listing of vessel's statutory certificates, securing equipment, amongst others.

# Procedures for Requesting a Flag State Inspection

To coordinate the Flag State Inspection in a port of convenience shipowners and/or operator shall send an email to asi@imd.com.pa containing the below information

- Vessel name
- IMO
- Call Sign
- Vessels rotation (three calling ports)
- Estimated Time of Arrival
- Local agent contact details

# REQUIREMENTS TO BE APPROVED AS A FLAG STATE INSPECTOR

Flag state inspector should have the following professional qualifications, wherever possible:

- I. A Certificate issued under the relevant provisions of the STCW Convention, as amended, as:
  - I-I Master, enabling that person to command a ship of 3,000 GT or more.
  - I-2 Chief engineer, enabling the person to command the machinery installed in a ship powered by main propulsion machinery of 3,000 KW or more.
  - I-3 Meet the provisions of the Radio Regulations or hold an appropriate Certificate related to GMDSS.
- 2. A university degree or diploma as a Naval Architect, Mechanical Engineer, Electrotechnical Engineer, Engineer whose Professional Education relates to the maritime industry.
  - Not less than five year service as an officer on board a Ship at sea, or in a capacity as naval architect, or as an engineer in the maritime field.
- 3. A relevant university degree or diploma, must be augmented by completion of the IMO model courses:
  - 3.1 Machinery
  - 3.2 Electrical Installations
  - 3.3 Fire Appliances and Provisions
  - 3.4 Life-Saving Appliances
  - 3.5 Hull
  - 3.6 Navigation and has relevant sea- service of not less than six months, or a document to prove any experience or update knowledge in relation of the Maritime Industry or any Maritime Organization.

## **COLLATERAL SERVICES**

#### **SEAFARERS LICENSES:**

#### PANAMA

In accordance with IMO regulations as amendment, officers and crew onboard aboard Panamanian vessels must possess valid documentation establishing their professional qualifications.

Panamanian titles are obtained through endorsement of a valid title complying with STCW Manila Amendments for the STCW Convention and Code and issued by a White List country.

Nationals of a White List country shall seek direct endorsement of their home license, while residents will have to demonstrate additionally that they were trained in a center recognized by the maritime administration of a White List country.

Upon reception by email of the supporting documents of our candidates our office send soft copy by email of a Transitory Certificate (CT) with validity of three (3) months. The full term license are issued within 25 working days and this will be send via courier to the client.



#### **BELIZE**

Isthmus Marine Documentation (IMD) is an Authorized Seafarers Agent for INTERNATIONAL MERCHANT MARINE REGISTRY of BELIZE (IMMARBE).

The procedures for the issuance of Officers Endorsements by IMMARBE are based on equivalence, requiring evidence that the candidate hold an appropriate, recognized and valid certificate from a country that is on the IMO White List.

IMD has been authorized by IMMARBE for aiding the maritime community by providing the seafarers the following services.
